

**BUYER'S DISCLOSURE AND AGREEMENT FOR
INSTALLATION OF A VEHICLE STARTER INTERRUPTION
DEVICE AND GPS TRACKING SYSTEM**

SECTION 1: MY UNDERSTANDINGS

- A.** I understand that The Dealer has equipped The Vehicle with a vehicle starter interruption device or a GPS tracking system or both ("The Device"). The Device will allow The Dealer to locate The Vehicle in the event of a default or theft. I understand that the cost of The Device, as well as the cost of installation, was not directly or indirectly charged to me. The Device is partly designed to ensure that I provide The Dealer with any and all stipulations that may be required to secure financing for the vehicle. The Device is also designed to ensure that I maintain prompt and timely payments on The Vehicle as agreed to in The Contract as well as maintain physical damage and liability insurance as required by The Contract and the law.
- B.** I understand that **I MAY NOT BE ABLE TO START** The Vehicle if I do not provide The Dealer with the necessary documents or down payment required to secure financing or if I am determined to be in default of The Contract for any reason.
- C.** I understand that if The Device is activated, in order to restart The Vehicle if it is disabled, I will need to bring The Contract and the required stipulations, down payment, payment or proof of insurance to The Dealer or its assigns in order to have The Vehicle enabled to start again. If the required stipulations, down payment, payment or proof of insurance is not promptly provided to The Dealer or its assigns, The Dealer or its assigns may talk any and all actions permitted by law up to and including repossession and sale of The Vehicle.

**SECTION 2: MY ACKNOWLEDGEMENTS-CONSENT FOR
INSTALLATION AND OPERATION OF THE DEVICE**

- A.** By signing below, I am acknowledging the fact that The Vehicle was equipped with The Device, that consent to the installation of The Device and purchase of The Vehicle from The Dealer is my choice and that if I prefer to buy a vehicle that does not have a starter interruption device or GPs tracking system, that I am free to find an alternative seller of automobiles.
- B.** By signing below, I am acknowledging my understanding and acceptance of the terms and conditions of this agreement regarding the installation of The Device,
 - 1. I understand and agree that I may be able to purchase a vehicle from another dealer who may not require The Device to be installed on The Vehicle, but am choosing to purchase The Vehicle and consent to having The Device installed.
 - 2. I understand that I am not the owner of The Device. I will **NOT** tamper, alter, disconnect or remove The Device. I agree to reimburse The Dealer or its assigns for repairs to or replacement of The Device made necessary by any attempt I make or have made to disable or tamper with The Device unless the law provides otherwise.
 - 3. I understand that The Dealer or its assigns may engage The Device to enable the starter interruption system or the GPS tracking system if I fail to abide by or am deemed to be in default of the terms of The Contract. If the starter interruption system is engaged it will hinder the ability to start The Vehicle. The GPS tracking system will also allow The Dealer to Locate The Vehicle.
 - 4. I understand that if The Device is used to disable The Vehicle it may not start until I bring the necessary documents or payments to The Dealer or its assigns to relieve the cause of the default. I understand that The Dealer or its assigns may not be able to re-enable The Vehicle if the battery is not fully charged.
 - 5. I understand that only The Dealer or its authorized agents may perform maintenance on The Device or any of its components.
